# DMP Rental Payments (WA)

DMP now require for rental payments being made by EFT that an <u>"intention to pay"</u> be produced, prior to making payment, using Mineral Titles Online.

To produce the intention to pay, log in to MTO, click on 'Online Transactions', click on 'make a rental payment' on the bottom left hand side of the page and follow the steps. This intention to pay will be emailed to you with a reference number for you to process the rent by EFT quoting the reference number. Once DMP receives the money, a receipt will be emailed to you.
